Young Saver Accounts can be opened by adults for children from birth to under 16 years of age, who live or study in Shropshire. Membership is free, and Young Savers can save as little or as much as you wish. There are no charges for paying in or withdrawing money from the account, and Young Savers are eligible to receive an annual dividend.

- Valid picture driving licence (*if less than 3 months old*)

Withdrawals from the Young Saver Account to a bank account are only to the nominated parent or guardian’s bank account. Call 01952 200200 during customer service opening hours and our helpful, friendly team will transfer money to the nominated bank account. Funds are usually in your bank during the same working day, and there is no charge for this service.

Withdrawals can also be made in person by the Nominated Adult / Guardian (if the child is under 12 years old) or by the Young Saver Member (if 12 years or older) from FAIRshare’s Telford or Shrewsbury branch.
