# **How To Join FAIRshare**

Everyone who lives, works or studies in Telford or Shropshire, or works for a Telford or Shropshire based company, can join FAIRshare. You can join FAIRshare online, or in person at our Telford branch or Shrewsbury office, or at a FAIRshare Information Point.

To Join FAIRshare -

- 1. Complete both sides of this application form
- 2. Pay you membership fee and deposit your first £5
- 3. Provide proof of identity and your address

# Membership fee

There is a one off non-refundable £5 membership fee, payable when joining FAIRshare. You must also deposit £5 into your account, which is your first "share" in your Share Account – a savings account like an instant access saving account. There are no charges for paying in, withdrawing, transferring money or running your account.

### Identification

We are required by law to take two recent & original forms of identification to confirm both identity and address.

Please bring along ONE item from EACH list, to join FAIRshare –

# List One - Proof of Identity:

- · Valid signed passport
- Valid UK/EU photo driving licence or full UK (old style) driving licence
- · Confirmation of state or local authority benefit entitlement (issued in the last 12 months)

• Utility bill

- Tenancy Agreement
- Confirmation of state or local authority benefit entitlement

- Bank, Credit Card or Mortgage statement (posted to your address & NOT printed from the internet)
